#### FROM THE PRESIDENT

This last column as President of the Division has been the hardest to write. It is hard to say goodbye to this position; I know how much I had hoped to accomplish and how much still remains to be done. I am humbled by the commitment, dedication, and hard work of so many people, and by the trust given to me, the rest of the Executive Board, and to the hard working committees. I did not elect to have a single major Presidential Project; instead, I decided to develop and/or support a series of smaller projects that were collaborative with other groups. Here is an update on these various projects.

In planning these projects, I reviewed the divisions and other groups with which we had significant overlap in membership, assuming that would reflect two things: 1) that there would be a significant number of counseling psychologists in those divisions-even more than the overlap in membership would suggest; and 2) that we would have interests and goals in common. So, here are the projects!

- Development of the Council of the Specialty
  of Counseling Psychology (CSCP) which
  represents Division 17; the Student Affiliate
  Group; the Council of Counseling
  Psychology Training Programs; Association
  of University and College Counseling Center
  Directors; ABPP-Counseling; Academy of
  Counseling Psychology; and Association of
  Counseling Center Training Agencies, and
  which elects our representative to the Council
  of Specialties.
- Miniconvention developed for Convention 2000 with Division 42 (Psychologists in Independent Practice) on Psychologists Creating Impact, including workshops on advocacy, leadership, and media presentation. Also includes presentation of awards for leadership in public policy to US Congresspersons Ted Strickland (D-OH) and Brian Baird (D-WA).

- Joint midyear Executive Board meetings, including a workshop on bridging the gap between science and practice, with Divisions 29 (Psychotherapy) and 43 (Family).
- Joined the Interdivisional Healthcare Committee with Divisions 22, 38 (Health Psychology), and 40 (Clinical Neuropsychology).
- Submitted an interdivisional grant to support development of materials to assist divisions in increasing minority participation; with Divisions 22 (Rehabilitation), 35 (Psychology of Women), 42 (Psychologists in Independent Practice), 44 (Society for the Psychological Study of Lesbian, Gay and Bisexual Issues), 45 (Society for the Psychological Study of Ethnic Minority Issues), and 51 (Society for the Psychological Study of Men and Masculinity).
- Supported the second National Multicultural Conference and Summit to be held January 25 and 26, 2001, with Divisions 35 and 45.
- Supported the National Conference on Counseling Psychology with CCPTP.
- Facilitated the ongoing work on the Guidelines for Multicultural Competence with Division 45.

All of these-and other projects-reflect my interest in collaboration and in the great possibilities we have when we join our strength with others. It is through shared interests and abilities that we build our greatest capacity to affect the world. Thank you for the opportunity to join the leadership of our Division in these wonderful efforts. This has been a terrific year.

#### FROM THE PRESIDENT-ELECT

In the April Newsletter, I wrote about the two conferences next spring, the 2nd Multicultural Summit and the 2001 National Conference in Counseling Psychology. In this column, I'd like to let you know more about the national conference which I am co-chairing with Bob McPherson, and which is my presidential initiative. Elsewhere in this Newsletter, there is an announcement of the conference with information on the dates and contact information. Here I'd like to introduce you to the committee chairs, and tell you more about the planning for the conference.

· One committee is charged with gathering information about counseling psychology. Some of you received a survey asking specifically your ideas about the conference and areas you would like to see covered in the conference. That survey was put together Rod Goodyear, by Jim Licthenburg, Bob McPherson, and Nancy Murdock. They are also putting together another survey that will replicate and extend the survey done in the 1980's about counseling psychologists' beliefs and attitudes about their training and the places in which they work. The latter survey will go out to a sample of counseling psychologists who belong to Division 17, as well as to counseling psychologists who belong to APA, but do not belong to the division. One of our major goals is to find out ways to be more inclusive of counseling psychologists in a wide variety of settings. While we cannot meet the needs of everyone, we want to learn how to do a better job of reaching out to counseling psychologists who are not in traditional roles.

Many of the individuals who responded to the survey about the conference told us NOT to do "business as usual." In other words, while many find the APA convention stimulating, they did not want this national conference to be another "mini-APA." We couldn't agree more, and so we are planning a variety of activities and ways that individuals can be involved in shaping the future of counseling psychology.

 There will be symposia and poster sessions, but with a focus on allowing time for discussion and lots of time for roundtables.
 The program committee is co-chaired by

- Sam Buser, a psychologist in private practice in Houston and President of the Texas Psychological Association, and Madonna Constantine of Teachers College, Columbia University. A call for papers will go out in mid-June, and proposals will be due in mid-September.
- In addition to the traditional presentation formats, there will also be social action groups. This committee, co-led by David Blustein, Boston College, Nancy Elman, Pittsburgh, University of Larry Gerstein, Ball State, will organize small working groups of between 8-15 participants who will focus on a circumscribed set of issues relating to the major conference themes. These groups will meet each day of the conference with the goal of developing an action plan on a set of issues. The social action groups will seek to examine the broader political, economic, cultural, and historical circumstances of a given set of issues in order to situate counseling psychology's concerns in their natural context. The social action groups will seek to link their activities to similar initiatives within our field and more specifically to any relevant initiatives that emerge from the Teachers College Roundtable and the Multicultural Summit. Outcomes for the groups may include: a research agenda, preparation of a policy paper, development of a political action initiative, design of a new training/ curriculum innovation, or a task force to examine a set of issues in more depth.
- We have two suites that we will be able to use for meetings of small groups, sections, and other constituent groups that may not always have time to meet at APA. This committee is co-chaired by Kathy Bieschke, Penn State University, and Loreto Prieto, University of Akron.
- We will have a number of continuing education workshops focusing on skill building. These result from a very strong request from counseling psychologists who are private practitioners. This committee is co-chaired by Stephen Cook, Texas Tech University, David White, Executive Director of the Texas Psychological Association, and Tammi Vacha-Haase, Colorado State University.

- A town hall meeting will be the capstone
  of the conference. This meeting will be
  held on Sunday morning of the conference
  and will be a time to pull elements of the
  conference together. This committee is
  co-chaired by Angela Byars, University
  of Wisconsin-Madison, and
  Greg Neimeyer, University of Florida.
- We are committed to explicitly linking the national conference to the Multicultural Summit. Linda Forrest, Michigan State University, and Emil Rodolfa, University of California-Davis Counseling Center, are co-chairing a group that includes the Section chairs to find ways to link the programs of each conference together.
- We are also committed to finding ways to reach out to a variety of groups and counseling psychologists in many other settings. Jose Abreu, University of Southern California, and Hope Hills President of Circle Consulting, are co-chairs of publicity and are actively working on that (as evidenced by the announcement in this Newsletter that they have submitted).
- Also in support of our communication is the web site committee, co-chaired by Paul Gore, Southern Illinois University and Elizabeth Vera, Loyola University.

Planning is well underway, and there are many opportunities to volunteer and be part of this 4th conference in counseling psychology. Please mark your calendars to attend on March 2-4, 2001! If you want to be part of this historic event, please contact me at:

#### FROM THE VICE-PRESIDENT FOR DIVERSITY AND PUBLIC INTEREST

The 2000 APA Convention in Washington, DC looks to be a pivotal convention for the Division in the area of Diversity and Public Interest, with a number of programs and activities on the slate. Once again, the various Division sections will be engaged in roundtable programs to focus on issues relevant to each section. The Division's newest section, Section on Prevention and Public Interest, will be included in the sections' roundtable program. Additionally, the sections will once again sponsor a poster session during the Monday night social to showcase innovative graduate student research in counseling psychology.

Like last year, Division 17 will co-sponsor a joint social with Division 45 on Saturday (8/5) from 5:30 - 6:50 p.m. Note that the time in

your convention program will list this as starting at 6:00 p.m., but it will really begin at 5:30 p.m. (Too long an explanation...trust me on this one!). The highlight of the social will be a recommitment of both Divisions to our shared pledge in celebrating and affirming diversity and to renew our shared goal of collaboratively advancing the work on the Multicultural Counseling Competencies. I would encourage all of you to attend.

An update on the e-journal project - Thomas Palma (Chair, SLGBA) will be coordinating a pilot of the electronic journal project working collaboratively with SERD and SAW. This looks to be an innovative means of fostering continued research in multicultural issues as well as to continue the Sections' dedication to mentoring graduate students and welcoming new professionals into the Division.

Lastly, the APA Congressional Fellows have recently proposed a program that focuses on

giving back to the community (e.g., volunteer service to community agencies) that hosts the annual APA convention. There are other professional organizations that already have programs (a.k.a., Service Learning Programs) such as this in place (e.g., American College Personnel Association; ACPA). I believe that this would be a prime opportunity for the Division to become involved in making concrete its commitment to social justice and advocacy.

#### The Division 17 Endowment Fund

The Development and Growth of the Division 17 Endowment Fund.

The Division 17 Endowment Fund of the American Psychological Foundation was established during Dr. Bruce Walsh's Division 17 Presidency to sponsor innovative projects that support the practice and science of counseling psychology and further the goals of Division 17. In this Endowment Fund, the principal will be preserved and the income earned will be used to sponsor and support innovative projects. Currently, the principal is valued at \$50,000. The interest earned since the Fund's inception has accumulated and is valued at approximately \$3,000. We are seeking to increase the principal by requesting donations from Division 17 members. As the principal in the Fund increases, Division 17 will be able to support more projects or larger projects with the accrued interest. ## Submission of Proposals for Requesting Funding from the Division 17 Endowment Fund.

The Endowment Fund has been established to support innovative projects such as broadly focused scholarly activities or research projects, public policy initiatives, conferences, workshops, or continuing education programs, that further the strategic goals of Division 17. Any one who is a member, fellow of Division 17, or its Sections, SIGs, or the Student Affiliate Group is eligible to apply and may submit a proposal for consideration for funding. Proposal should include: (a) a 250 word executive summary, (b) a budget proposal for the entire project indicating how Division 17 Endowment Funds would be used, (c) description of other funding and resources to support the project, (d) other sponsors or supporters, if any, of the project, (e) a detailed timeline, (f) an indication of the anticipated

impact of the project on the field of counseling psychology, and (g) a summary of the qualifications of the individuals who will be involved in the project. Proposals will be reviewed by the Endowment Fund STG and recommendations will be made to the Division 17 Executive Board who will make a final decision about who will receive Endowment Fund money to support their project. Deadlines for submission of proposals is January 1st and July 1st of each year. Executive Board decisions will be made in February and August of each year. According to the APA Ethical Principles of Psychologists and Code of Conduct, Principle F, psychologists "are encouraged to contribute a portion of their professional time for little or no personal advantage."

It has been estimated that 10,000+psychologists attend the APA Annual Convention. This influx of professionals for the week offers the potential for significant contribution to the city's volunteer base during the week of the Convention. Currently, there is no coordinated effort to encourage attendees to participate in any sort of donation of time, energy, and expertise to the betterment of the city in which the Convention takes place. Similarly, there are no large-scale

efforts to promote volunteer service in members' home communities.

In order to rectify this situation, we are asking APA Divisions; State, Provincial, and Territorial Psychological Associations; and APAGS to appoint a representative and commit to the following plan. Assign a representative of your group to assist with recruiting members to participate in the program. We will help this person match volunteer opportunities to the group's interests. This proposal has the support of L. Michael Honaker (APA Deputy CEO) and Judy A. Strassburger (Senior Director, APA Governance Affairs).

Our goal is to have each person attending the APA Convention provide at least two hours of volunteer work in the city where the Convention is held and have each psychologist/graduate student who does not attend the Convention provide at least two hours of volunteer service in his or her own community during the week the Convention takes place. Our hope is that those who volunteer while at the Convention will have a positive experience that will inspire them to continue volunteering when they return home, and that those who start by volunteering

for a couple of hours at home will make an ongoing commitment.

As you know, this year's Convention will be held in Washington, DC. We have a list of agencies in DC with missions related to areas of traditional interest to psychologists which are interested in having small groups of one-time volunteers (e.g., organizations serving the homeless, children, older adults). We also can assist with arranging community workshops (e.g., at a church or school) or outreach opportunities (e.g., with a needle exchange program designed to prevent the spread of HIV disease) on subjects in which psychologists have expertise (e.g., ADHD, violence prevention, substance abuse treatment).

Ideally, we would like to see the program associated with already organized Convention activities in which your group will be participating (e.g., social hours) so that members could be signed up during these activities.



Editorial Policy: As counseling professionals realize the increasing diversity in their communities and the profound influence of culture on the efficacy of clinical and educational initiatives, the need for multicultural research and knowledge becomes apparent.

The E-Journal of Muticultural Issues in Counseling Psychology is a scholarly, professional journal devoted to increasing the understanding of cultural influences in our world and to facilitating the multicultural initiatives of new and future scientist-practitioners in counseling and psychology.

#### **E-MICP** objectives:

- To increase our understanding of the influence of culture in our world.
- To promote cooperation among mental health practitioners working with minority and other marginalized populations.
- To facilitate the promotion of scientific perspectives not aligned with a dominant world view.
- To initiate young academics and graduate students in counseling psychology into scientific and research orientated initiatives.

Journal Content: The journal will welcome theoretical and empirical contributions,

- A process of peer-review will be accorded all submissions to the E-MICP.
- More than 70% of articles published in E-MICP will be empirically or theoretically driven, with distinctions between these and commentary or revieworiented articles being made for archival purposes.
- All articles will adhere to the manuscript guidelines of the APA Publications Manual, including those addressing language, style, and ethics.
- The "instructions to authors" will also adhere to APA policies and demand compliance to APA manuscript preparation guidelines.
- The E-MICP will afford PsychINFO and PsychLIT gratis use of journal abstracts.

The E-MICP will be provided to the entire community of psychologists and mental health professionals and trainees for a period of one year – at which time subscriptions will be available to this network of scientist-practitioners and trainees. #### **Call for Division 17 Fellowship Nominations**

Division 17 wishes to recognize its members who have had a significant impact on the specialty of Counseling Psychology within the areas of science, teaching and training, service delivery, administration, policy development, and/or advocacy. Fellowship is an honor bestowed upon members who have made "unusual and outstanding contributions or performance in the field of psychology." #### Obituary Dr. G. Frederic Kuder

Dr. Frederic (Fritz) Kuder passed away at his home on Sanibel Island, Florida, on April 2, 2000, at the age of 96. He described his career as dedicated to helping young people make satisfying career choices on the basis of a systematic survey of their interests. To this end he developed four different interest inventories, published in seven editions. Over a span of 60 years, they have been taken by more than a hundred million people in the US, Europe, and South America. He was also the author of several important articles on the measurement of interests, summed up in a 1977 book, Activity Interests and Occupational Choice. Kuder-Richardson formulas, developed in 1937 to assess the reliability of scales, continue to be widely used today. He was a founding member and the second president of the (now) Division of Counseling

Psychology of the American Psychological Association; co-founder of Personnel Psychology, and the founder and editor of Educational and Psychological Measurement.

Dr. Kuder was honored by Ohio State University's Centennial Achievement Award. He was the recipient of the E. K. Strong Gold Medal for his contributions to interest measurement, and the Leona Tyler Award for his sustained contribution to the field of counseling. Educational Testing Service presented him with their award for distinguished service to measurement. He is listed in American Men and Women in Science.

Dr. Kuder was the son of Frederic A. Kuder and Elizabeth Lablin Kuder. He was born on June 23, 1903 in Holly, Michigan, and spent his childhood in Menomonee, Wisconsin,

where his father was a Presbyterian mini He received a B.A. from the Universit Arizona, his M.A. from the Universit Michigan, and Ph.D. from Ohio S University. He began his career as an e for pioneering psychologist J. Mck Cattell's Science Press in New York City was employed in the personnel departs of Proctor and Gamble Co. He serve University Examiner at the Universit Chicago and retired as Professo Psychology from Duke University.

He was preceded in death by his v Dorothy Linn DeBeck Kuder, and his bro Merle S. Kuder.
