

FROM THE PRESIDENT

From my previous columns, you know about the theme I adopted for this year "Counseling Psychology: A Tribute to Uniqueness." As my term as President winds down, I want to review some of the activities focusing on capturing uniqueness. To enhance the strength and uniqueness of Counseling Psychology, a Division 17 Endowment Fund has been proposed to the American Psychological Foundation. The primary objective of this fund will be to sponsor projects that support, the science and practice of Counseling Psychology. It is my plan that by the time of the APA meetings in San Francisco the Counseling Psychology Endowment Fund will be established. Additional initiatives focusing on capturing uniqueness include the formation of a Roundtable of Section Chairs and the formation of a Past President's Council. Progress is being made on these initiatives and activities are planned for the APA meetings in San Francisco.

Accomplishments capturing uniqueness in the Science domain include the following. In March, 1998 an archival description of our specialty and the revised petition for the recognition of Counseling Psychology as a specialty within professional psychology were submitted to the Commission for Recognizing Specialties and Proficiencies in Professional Psychology (CRSPPP). APA grants specialty status to those areas of professional psychology that demonstrate distinctiveness with respect to the populations they serve, the problems they address, and the techniques or methodologies they employ. Specialty recognition is important because it informs the public about the nature and scope of services that psychologists provide, as well as the knowledge base accumulated. It is an

effort to communicate what psychologists do. The expectation is that the archival descriptions for counseling, clinical, and school psychology will be reviewed and accepted by the APA Council in August, 1998. CRSPPP will be reviewing the Counseling Psychology specialty petition in October 1998. Also of interest are the proposed guiding principles for establishing research support for systematic action programs developed by the Special Task Group on Empirically Validated Treatments. These guidelines focus on the relevance of science and practice for human welfare. The STG is preparing a manuscript that will discuss the rationale for the principles.

In the domain of Diversity and Public Interest, a Special Interest Group on Disabilities has been established. Those interested in working on and discussing these issues should contact Nadya Fouad or Kathy Chwalisz. Other initiatives in progress include the Multicultural Competencies Task Force, a Task Force focusing on the public image of counseling psychology, integrating the BAPPI overarching theme of valuing diversity into the Division planning activities over the next three to five years, a school to work proposal, and a social hour dedicated to celebrating diversity on Saturday, August 15. In regard to the school to work proposal, a Multi-Division Task Force has been formed to develop a pro-active role for psychology in contributing to the school-to-work movement.

In the Education and Training domain, relevant initiatives include the psychology internship supply and demand issue, postdoctoral program accreditation, the introductory curriculum for training in psychopharmacology, high school psychology standards, and master level training and credentialing. Division 17

was well represented at the APPIC/APA Supply and Demand Conference held in November, 1997. The purpose of the conference was to propose a set of strategies and action plans based on a review of supply and demand issues in professional psychology. In addition, plans are currently being laid out for a National Conference to be co-sponsored with CCPTP focusing on Counseling Psychology in the next millennium.

The Professional Practice domain has initiatives focusing on managed care, prescription privileges, and parity for mental health with physical health. An effort is being made to identify ways in which the practice sections of various divisions can collaborate on these initiatives. An additional initiative is pursuing professional development issues of practitioners over the life span, including such phases as new professional, mid career change, pre-retirement planning, and meaningful roles in the retirement years.

Finally, last year a home page was developed. This year the Web Site Committee and the position of Web Master were structured. The Web Site Committee reviews submissions, additions, changes or updates to the home page in communication with the Web Master. This review is carried out in the context of the Web Master Policy Statement recently developed. To keep abreast of rapidly changing technology, a STG has been formed to focus on future planning and trends.

I want to thank the Executive Board for their very hard work during this busy year. In August, Louise Douce will complete her term as Vice President for Education and Training, John Westefeld as Treasurer of the Division, and Gerald Stone will complete his term as Past President. Louise has done excellent work as a Vice President and been a very strong advocate of the Division. John has improved the financial status of the Division, protected our funds, and assisted in making good use of our funds. Gerald Stone has given excellent leadership and support to the Division for many years.

The above reflects on past and present initiatives. For a view of future initiatives focusing on capturing uniqueness read the rest of the newsletter, attend the programs at the convention, enjoy the activities in the Hospitality Suite, and last but not least become active in the Division.

Finally, I want to express my gratitude to the hundreds of members who worked on behalf of the Division this year. I enjoyed serving as your President most of the time. Thank you for the opportunity. See you in San Francisco.

managed care accountable for negligence through legislation called Patient Access to Responsible Care Act (PARCA). There is bi-partisan support for this proconsumer legislation and APA has publicly supported it along with the American Medical Association, American Dental Association, and American Occupational Therapy Association. Look for updates on this legislation.

Other legislative issues: An older piece of legislation, the Campus Security Act of 1990, is still haunting some university psychologists. This piece of legislation, although well intended, asks campus officials to report on certain crimes (such as rape), but that puts mental health professionals into a bind ethically. While psychologists are neither included nor excluded from the wording of this legislation, the ambiguity leaves it open to interpretation on an institution by institution basis. If your campus is affected negatively by this legislation please let me know, as we are working with the Practice Directorate and its lobby efforts to amend this act to exclude mental health professionals from the requirement to report.

Academy of Counseling Psychology (ACoP). See other newsletter article (p. 9) about members of the academy forming a new section in Division 17...which will provide closer links for communication between members of Div 17 and the Academy. On Definitions, Decisions, and Dignity...

Last December I received a call from Dr. Gerry Stone informing me that I had been nominated by my colleagues to serve as Division 17 Council Representative for 1998. Prior to his call, I had not been approached by any Division 17 members about this nomination, so I was both surprised and flattered by the call. After receiving Dr. Stone's official letter informing me of my nomination, I indicated my willingness to have my name placed on the 1998 ballot, and I later prepared and submitted my biogra-

phy and personal statement which appeared in the April 1998 issue of the Division 17 newsletter. Following publication of that newsletter, I was approached by a member of my progra Dr. Linda Forrest, who voiced concern that my name appeared on the ballot, as it was her understanding that the Council seat for 1998 was to be restricted to a minority representative. As a member my program, Dr. Forrest has been awar that I do not consider myself to be of Hispanic/Latino descent nor a member a protected group. I am a secondgeneration Spanish-American, and my grandparents on both sides were Spanis citizens. My mother is also a native Spaniard and naturalized American citizen. Although definitions of "Hispanic" have varied over the years, the most current data available indicate that persons who self-identify as Hispanic typically describe their ethnic/ancestral origins as Mexican, Puerto Rican, Cuban, or Central/South American (U.S Census Bureau Official Statistics, 1993

I regret that I was not aware of, nor was reminded of, the nature of this "special election" when I was first informed by Dr. Stone of my nomination as Council Representative. Had I been, I would have declined the nomination at that time. Given the circumstances, howeve I chose instead to withdraw my candidacy for this seat and I immediately informed Dr. Stone of my decision. Withis assistance, my name was dropped from the official ballot in late April.

This entire episode, while awkward and unpleasant, has enabled me (once again) to reflect on my own ethnic identity and to clarify my identity to those who migh otherwise be inclined to form erroneous conclusions. I am proud of my Spanish heritage, of my parents' lifelong sacrifices to support their children's dreams, and of their unwavering message to me and my siblings to refuse any award, recognition, or assistance from any source that was not based on our merit, ability, or achievement. It is unfortunate that we exist in a society wherein ethnicity, achievement, and support/ recognition have become so hopelessly confounded. It is unfortunate that we have created institutions and policies (even some well-intentioned ones) that

make it difficult, if not impossible, for competent, capable people of particular races and ethnicities to experience their life successes as "earned". My parents' message and their support helped me navigate this treacherous terrain, and, in recent weeks, this lesson "came home" to me in yet another way. Earlier this spring, my high-school senior daughter received two unsolicited four-year (full) scholarships to attend major state universities as a National Hispanic Scholar. She has politely declined both. As difficult as it is to turn down tens of thousands of dollars, I am proud of her ... and in taking the action of withdrawing my name from the "special election" for Division 17 Council Representative, I am proud of myself. My time and energy will be better spent helping my daughter create a life wherein her work and accomplishments are judged on their own merit and not on the basis of presumptions others make about her last name ...

ABPP INFORMATION

As psychology moves toward greater recognition of specialization in the profession, it becomes increasingly important to counseling psychology to nurture and sustain board certification for counseling psychologists. Counseling psychology was one of the three original specializations of the American Board of Professional Psychology (then [ABPP], the American Board of Examiners in Professional Psychology) established by a grant and at the behest of APA in 1947. About 225 practicing counseling psychologists are currently board certified and are ABPP Diplomates in Counseling Psychology.

The American Board of Counseling Psychology (ABCoP) and the Academy of Counseling Psychology (ACoP) are now the two organizational structures representing counseling psychology in ABPP. The Board is charged with the development and administration of the examination in counseling psychology; while the Academy is the professional arm and represents Diplomates in Counseling Psychology. The Academy also has affiliate status for non-diplomate counseling psychologists who are contemplating taking the board examination. There is an opportunity for board certified counseling psychologists who are members of Division 17 to work in collaboration with the Division in an effort to develop greater interest in this level of specialty credentialing and in the furthering of professional identification within the specialty of counseling psychology. I would like to see the members of the Academy of Counseling Psychology organize a section of the Division devoted to promoting board certification in counseling psychology.

The section on board certification would be able to respond to the questions of those division members interested in board certification and to the needs of Division members who were board certified. The section would also provide a juxtaposition between APA Division 17 and ABPP's Academy of Counseling Psychology and allow for significant dialogue and interaction between these two groups for the benefit of the specialty.

The Diplomate in Counseling Psychology: What's in it for me?

At the CCPTP Mid-Year Conference in Phoenix, Arizona I made a short presentation about the procedures and logistic of applying for Board Certification from the American Board of Counseling Psychology (ABCoP) - the Counseling Psychology branch of the American Board of Professional Psychology

(ABPP). The presentation covered the who, what, when, where, and how of the process. Afterward a number of Training Directors commented that what was missing from the presentation was some comment on "why" one would seek the ABPP Diplomate. This short piece is my personal statement of why the ABPP has proven to by a significant achievement and designation.

Practitioner Benefits

As I reflected on the benefits to me as a practitioner, I came to the following four points:

- 1. At a local hospital, where hospital privileges were granted to psychologists, the application was seven pages long. The exception came on Page 1 where there was a little box that indicated the ABPP credential. If one checked "yes," then the remaining six pages of the application were unnecessary. As one of my colleagues phrased it, "The medical profession understands "Board Certification."
- 2. While even a doctoral degree can prove to be something of a disadvantage for managed care panels in terms of selection for service delivery, the upside of the ABPP is that it can provide an entrance to panels which might be closed since panels often have to demonstrate the quality of the services they promise to deliver. The Diplomate designation makes holders attractive to managed care organizations since it is a clear designation of quality.
- 3. Demonstrating competence, as a witness in court testimony, for example, is greatly enhanced by the ABPP credential. Again, in my own limited experience, I was accepted immediately as an expert witness once identified as a Diplomate in Counseling Psychology. While my experience is limited, my conversations with others has verified my personal experience.
- 4. I recently moved from one state to another and while there was no formal reciprocity my application for licensing was greatly aided by the Diplomate. The Academy for Counseling Psychology, the advocacy arm of ABCoP, is working

on just such reciprocity agreements now.

Academic Benefits
Five benefits were clearly evident after I obtained the Diplomate:

- 1. When our program applied for APA accreditation, both the Application and the Site Team were interested in the number of faculty holding ABPP status. This seems especially true for those programs which lean toward a greater focus on preparing practitioners.
- 2. The Diplomate models for students the recognized achievements of a faculty member. We may have forgotten but I invite each of us the think back to the time when we looked to our professors as models and mentors into the profession. As graduate students, we took pride in the accomplishments of our teachers. ABPP certification is a concrete example of professional achievement and student comments over the years have demonstrated to me the worth they see in it.
- 3. Beyond retention, tenure, and promotion, the Diplomate can pave the way to positions such as the Director of Training (TD) for a program. Obviously, many academic TDs do not currently hold the ABPP. Give some thought to this scenario, however. If the Department Chair or Dean is considering two candidates for the position. One with a Diplomate and one without other things being equal, who will be selected?
- 4. In addition to advancement within one's current position, the Diplomate does contribute significantly to upward mobility within the profession. Once attained, the Diplomate becomes an important credential for all future academic positions. This is especially true for any program seeking APA accreditation and seeking a person for a position of leadership.

Personal

The Diplomate in Counseling Psychology is the single most significant recognition by peers of practical competence we have in our discipline. It is for this reason that being recognized as a

CALL FOR DIVISION FELLOWSHIP NOMINATIONS

The Division 17 Fellowship Committee invites nominations of Division members for potential election to Fellow status in the American Psychological Association. A new deadline for submission of materials to APA has necessitated earlier deadlines at the Division level. The deadline for receipt of nominations is September 1, 1998. The deadline for receipt of application materials (i.e., nominees' materials and endorsers' letters) is October 15, 1998. Late applications will not be considered in the current review cycle. Nominations may be made by any member or Fellow of the Division; self nominations are accept-

Under the Bylaws of the American Psychological Association, Fellowship is an honor bestowed upon members who have made an "unusual and outstanding contribution or performance in the field of psychology." Division 17 wishes to recognize its members who have had a significant impact on he specialty of counseling psychology within the areas of science, teaching and training, service delivery, administration, policy development, and/or advocacy. Seniority or professional competence alone is insufficient to achieve Fellowship. Fellows' contributions are seen as having enriched or advanced Counseling Psychology well beyond that normally expected of a professional psychologist.

To be considered for Fellow status, members must meet both APA and Division requirements. APA requirements include: (a) the receipt of a doctoral degree based in part upon a psychological dissertation, or from a program primarily psychological in nature, and conferred by a graduate school of recognized standing; (b) prior membership as an APA member for at least one year and membership in the Division through which the nomination is made; (c) active engagement at the time of nomination in the advancement of psychology in any of its aspects; and (d) five years of acceptable professional experience subsequent to the granting of the doctoral degree. Division 17

additionally requires: (a) current engagement in education and training, practice or research in counseling psychology; (at least three of five years of post-doctoral professional experience in counseling psychology; and (c) membership in the Division for at least one year

Nominees for Fellow status will be asked to complete the APA's Uniform Fellow Application and related materials, and t solicit evaluations from three or more APA Fellows, at least two of whom mu be Fellows of Division 17. Completed applications are reviewed by the Fellow ship Committee, which submits its recommendations to the Division's Executive Board: nominations are sent forward to the APA's Membership Committee for final approval. Member of the Fellowship Committee or Executive Board who submit evaluations of a nominee do not vote on that nominee. New Fellows are announced at the Division's annual business meeting during the APA Convention.
