I am very excited about the APA convention! I will highlight just a few of the events, but know that this is only the “tip of the iceberg.” **Patricia Frazier** and **Richard Lee**, Program Co-Chairs, have assembled a very special convention program. For example:

- The day before the conference, the Society is co-sponsoring (with Divisions 42, 45, and the APA Board of Professional Affairs) an innovative pre-convention workshop titled *Multicultural Competencies for Practitioners: Implementing the APA Guidelines in Your Practice* (Wednesday, August 17, 1-5 p.m.). The presenters of this special workshop are **Thomas Parham** and **Louise Douce**; the workshop will be chaired and moderated by **Jaquie Resnick**, who has for the second year spearheaded this offering for the Society. - The convention program itself hosts an array of very impressive presentations; see the program summary in this issue. Many of our members will be happy to know that the Program Co-Chairs and the Continuing Education Chair, **Tammi Vacha-Haase**, have arranged CE credits for 25 of the 30 symposia!
- I also want to especially encourage members to attend the Leona Tyler address by one of the Society's outstanding scholars and leaders, **Bruce Walsh**, at 3 p.m. on Friday.
- There will be an impressive array of Fellows addresses (**Patricia Arrendondo**, **Michele Boyer**, **Silvia Sara Canetto**, **Carol Goodheart**, **Mary Heppner**, **Thomas Krieshok**, **Jeanne Manese**, **Karen Taylor**, and **Judith Worrell**) from 4-6 p.m. on Friday.
- A new forum has also been established for this convention to showcase our Best Science and Practice; **Clara Hill** and **Melba Vasquez** will present the inaugural cutting-edge science and practice presentations at 9 a.m. on Friday.
- Also as a follow-up to the fourth Multicultural Summit, I am particularly pleased that **Melba Vasquez**, **Sandra Shullman**, and **Rosie Phillips Bingham** have organized and will moderate a two-hour Difficult Dialogue, *Increasing Multicultural Understanding: Promoting Collaboration in the Face of Conflict Within Marginalized Groups* (Friday, 1-3 p.m.).
- In addition, I am excited to resume a slightly different International Forum symposium consisting of all international scholars, who this year will address the state of counseling in their countries entitled *Development of Counseling in East Asia* (**Myungia Keum**, **Dong Min Kim**, **Young-Seok Seo**, **Zhi-jin Hou**, and **Ping-hwa Chen**).
- Several convention activities have also been developed or expanded especially for graduate students and new professionals. **John O'Brien**, Chair of Section Chairs, has done a wonderful job in organizing and fine-tuning the student poster session; this

year there will be an all-time high of 45 student posters!

- **Karen O'Brien**, Membership Chair, has spearheaded a special inaugural roundtable, *You and Counseling Psychology: Charting the Future* (11 a.m. Friday), designed to provide students the opportunity to talk in small groups with leaders and new professionals about the counseling profession, and most importantly students' future in that profession.
- In addition, a special orientation (Thursday at 9 a.m.) and roundtable (Thursday at 10 a.m.) have been developed by **Yu-Wei Wang** and **Oksana Yakusko** for international students, *Mentoring and Fostering the Development of International Students in Psychology*.
- As in the past, our major socials will be held on Thursday, Friday, and Saturday from 5-7 p.m. I want to especially encourage members to attend the Friday social, where **Division 17 honors Division 45 with a 20th anniversary celebration!!**

**Saba Rasheed-Ali** (Hospitality Suite Chair) has organized an exceptional array of professional activities in the Society's Hospitality Suite; this year for the first time there will be three rooms of Suite activities for almost every hour of the convention! **Muninder Kaur Ahluwalia** has packed in a host of meetings sponsored or supported by the Society for our members. I want to strongly encourage interested colleagues to attend the Section and Special Interest Group meetings as these groups actively seek your participation. This year there will also be several special events in the Suite; I will highlight just a few:

- On Thursday at 8 a.m., for the first time we will join together with the Counseling Division of the IAAP (International Association of Applied Psychology). Their President, **Fred Leong**, and I will co-host the third International Scholars Breakfast and Reception. This session is designed to not only welcome our international guests, but also to provide a forum to exchange information and develop collaborative relationships.
- **Yu-Wei Wang** and **Oksana Yakushko** will conduct a reception and orientation for all international students at 9 a.m. Thursday. I am particularly delighted that 12 students led by **Li-fei Wang** from National Taiwan Normal University will be in attendance for this orientation.

- **Jim Lichtenberg** and **Nancy Elman** (Co-Chairs) have organized a special recognition of senior members who have made special contributions to the Society over the years (Friday at 11 a.m.).

As you know, the past presidents of the Society have shown a strong interest in **cross-cultural issues**, and **Louise Douce** focused her Presidential Initiative specifically on Globalization. One major theme of my Presidential initiative has also focused on promoting international issues in the Society; as a result, in collaboration with **Fred Leong**, **Karl Kwan**, and **Stewart Cooper**, we will hold several important meetings on international issues for members at the convention.

- My work in this area has been greatly facilitated by invitations to serve as keynote speaker at professional conferences in **Taiwan**, **South Korea**, **China**, **United Arab Emirates**, and **Singapore**, with additional keynote addresses planned within the next 12 months for **Italy** and **Greece**. These visits have enabled me to actively approach both international colleagues and leaders within respective international professional organizations in counseling to explore how we can collaborate to reach mutually beneficial goals. Specifically I have invited several international leaders in counseling to attend the APA convention, and we will hold a special meeting to discuss common goals and specific ways to collaborate in the future not only within the Society but also within the Counseling Division of IAAP. To facilitate attendance of our international leaders, with the generous support of Sage Publications, I was able to offer eight international counseling leaders **SAGE Fellows** to fund their registration costs for the APA convention. In addition, with the support of the Executive Board, the Society has approved a **\$17 membership fee for international affiliates** to ease the costs for international colleagues to become members of the Society.
- I also appointed a large **Special Task Group on International Issues** overseen by **Karl Kwan** and myself, and developed charges for 12 subcommittees involving over 20 colleagues from around the world. One subcommittee chaired by **Larry Gerstein** has focused on organizing an International Section within the Society. One initial criterion is to establish a

## FROM THE PRESIDENT-ELECT

### From the President-Elect

Plans for the Joint Midwinter Conference in 2006 with a focus on Immigration Issues that I described in my last column are moving along swiftly. The conference and divisional board meetings are set for the first weekend in February in San Antonio (on the River Walk!). Please note the date all Executive Board members, section chairs, etc. who usually attend the midyear meeting. The conference is being strongly supported by APA President-Elect Gerry Koocher as part of his presidential initiative. The conference will be underwritten by APA and all profits or losses will be assumed by APA. Hence, no fees will be required by divisions except the costs of our own members. Currently, 13 APA divisions are planning to attach their Executive Board meetings to the conference, with at least six other divisions sending liaisons. Full participants in addition to SCP include Division 35 (Psychology of Women), Division 45 (Ethnic Minority Issues), Division 42 (Independent Practice), Division 51 (Men and Masculinity), Division 29 (Psychotherapy), Division 16 (School), Division 37 (Child, Youth, and Family), Division 39 (Psychoanalysis), Division 43 (Family), Division 48 (Peace, Conflict, and Violence), Division 50 (Addictions), Division 54 (Pediatric), and Division 12, Section VI (Clinical—Ethnic Minorities). Of course, the conference part on Immigration Issues will be open to all SCP members, all psychologists.

The conference part will consist of an “experts summit” that will provide psychological perspectives on immigration. The working title is “Global Realities: Intersections and Transitions.” Potential topics include: immigration and trauma; intergenerational conflict and changes in gender roles and family systems as a consequence of immigration; psychotherapeutic approaches to immigration-related issues (i.e., cultural adjustment, racism, etc.); diversity of immigration populations—different nationalities, gender, LGBT, developmental perspective, family reunification, refugees, sojourners, visa status differences, undocumented immigrants, asylum seekers, migrants vs. immigrants; psychological consequences of intra-racial relations between recent immigrants and multigenerational Americans (e.g., African immigrants and their relationships with



African Americans). There is also a long list of potential speakers. I will let you know when the conference details are finalized.

In addition to the conference, we will have our usual Executive Board meeting and our meeting with the Section Chairs. I will be asking Board members and Section Chairs for input on what our joint meeting needs to accomplish this year. We used that meeting for priority setting and strategic planning in 2004, so we need to build further on that framework.

I am pleased to report that my Special Task Group (STG) on developing training models/modules/syllabi to provide guidance for integrating the various diversity guidelines is progressing under the capable leadership of Chair Marie Miville. Current members include: Changming Duan, Charles Waehler, Mary Fukuyama, Carol Enns, Terry Patterson, and Lisa Suzuki, with Ad Hoc Consultants Patricia Arredondo, Michael Duffy, and Jim Mahalik. Marie has gathered together resources and begun preliminary STG discussions via listserv and named the STG “Integrating Guidelines for Training and Practice Competency.”

I have reserved time at the convention in the Hospitality Suite for two of my appointed STGs to meet. The diversity integration STG will meet Thursday at 9 a.m. The Advocacy STG chaired by Bob McPherson will meet Friday at 10 a.m. I am still working on organizing other STGs I have mentioned and plans to continue the work of some STGs that Punky has begun.

The task force SCP is co-sponsoring with a number of other divisions on developing a set of guidelines for psychological practice with boys and men is beginning its work. Resources have been gathered and brainstorming sessions are scheduled by telephone and e-mail. The task force plans to meet in Washington, DC sometime this summer or fall. More on this later, also. The Interdivisional Task Force that developed the Guidelines for Psychological Practice with Girls and Women is still waiting for feedback from APA Boards and Committees.

I am looking forward to seeing everyone in Washington at the convention. Please feel free to send me ideas and concerns.

## VICE PRESIDENTS' REPORTS

### Vice President for Diversity and Public Interest

#### Reflections

I cannot believe how quickly my three-year term as VP for Diversity and Public Interest has passed. I have learned so much about the inner workings of our division as well as the APA organizational structure. I am continually impressed by the outstanding qualities of our membership and the dedication and passion of those involved in making this organization work so well. I realize more than ever that we are part of a major professional entity with constituent groups that span a vast array of priorities related to psychology. It has been my honor to work with some of the leaders and experts in the field of counseling psychology, and I am continually humbled by their warmth, generosity, and amazing expertise.

The promotion of diversity through APA policies (e.g., the Multicultural Guidelines) and the movement in terms of implementation in research, training, and practice are areas that I will continue to make a commitment to after my term is completed. The work of colleagues in this area serves as an example of what can be accomplished through perseverance and belief in a vision of change.

As a liaison to the Board for the Advancement of Psychology in the Public Interest (BAPPI), I came into contact with professionals from various divisions and constituencies of APA. The number of

committees that reported to the board at meetings was impressive, and the projects shared emphasize how important the work of APA is in providing services to people around the country and the world. We will be honoring the work of Henry Tomes, Ph.D., Executive Director of the Public Interest Directorate, at our business meeting at the 2005 convention.

There are a number of exciting programs to be held at this year's convention. Be on the lookout for a three-hour session with the Divisions of Social Justice entitled, "Effects of Global Conflict and War on Individuals, Families, and Societies (Chair: Robert Geffner, Ph.D.). Presenters will include Drs. Joseph Trimble, Judith van Hoorn, and Michael D'Andrea. The session will also include roundtable discussion groups on a variety of areas and an open forum to determine recommendations for policy change and interventions. Our liaison to the Interdivisional Committee on Teaching About Diversity, Dr. Muninder Ahluwalia, will be presenting as part of a symposium entitled, "Diversity Issues and Teaching of Psychology: Multidivisional Perspectives." There is a wealth of other presentations being sponsored or co-sponsored by our division related to issues of diversity and public interest. We will also be presenting a poster focusing on conducting within-community research.

I recently attended a refugee/torture

survivor conference sponsored by the FIRST Project (Lincoln, Nebraska) headed by advisory board member Maria Prendes-Lintel, Ph.D. The presentations included reflections regarding why clinicians worked in this field, examples of psychologists training members of communities to work with survivors, issues related to assessment of torture victims, and case management. Each presenter shared their work in the field as well as personal examples. Members of the audience included physicians, school counselors, academics, teachers, administrators, social workers, community caseworkers, etc. I left feeling rejuvenated and proud to be a part of a profession whose work impacts the lives of so many.

In closing, I would like to thank the members of the Society of Counseling Psychology for giving me this opportunity to be a part of the executive board for the past three years. It has been a great learning experience, and I am grateful to members of my advisory board, the executive board, section chairs, and other members of Division 17 governance for their guidance and expertise. I leave office with a renewed sense of commitment and resolve to contribute to the work of the Division in whatever capacity I can.

## VICE PRESIDENTS' REPORTS

### Vice President for Education and Training

The past couple of months have been busy! In addition to spending time monitoring the activities of APA's Board of Educational Affairs (BEA), I've primarily focused my energy on accreditation and the articulation of professional values.

In regard to BEA, my advisory board (Joyce Illfelder-Kaye, Penn State; Nadya Fouad, University of Wisconsin-Milwaukee; and Michael Johnston, University of California-Long Beach) and I formulated a response to a proposed workforce analysis of employment of psychologists. We are largely supportive of APA moving forward with this project, though we expressed some concern about the lack of acknowledgement of counseling psychology as a field, the scant attention paid to the master's-prepared workforce, and the inattention to employment issues relative to gender and race/ethnicity.

Relative to accreditation, I've been busy on many fronts. First, with the help of Nadya Fouad and Jenny Cornish (University of Denver), I submitted a response to a call for comments in regard to proposed language changes in the guidelines and procedures document of the Committee on Accreditation (CoA). In essence, our response articulated an

affirmation of broad and general preparation relative to the discipline of psychology and supported the removal of language that seemed contrary to the mission of the CoA. The response also disagreed with the suggestion that the "combined" option for accreditation be eliminated and that a fourth accreditation option termed "professional" be created. We also articulated the belief that specialty training should occur at the post doctoral level. This relates to my second accreditation activity, my participation in a Special Task Group (STG) focused on the creation of post-doctoral guidelines for specialty training in counseling psychology. Lynda Danley (West Virginia University) is ably chairing this STG, and the conversations that have occurred within the group have been invigorating and fascinating. Finally, I'm looking forward to traveling to Salt Lake City this June to attend the accreditation summit focused on the composition of the CoA. My hope is that the group assembled there will identify a composition for the CoA that is representative of both the values of the profession and the training communities contained within.

As I mentioned in my last column, a particular interest of mine is how we train our students relative to the values of the

profession. Laurie Mintz (University of Missouri-Columbia) and I are working with a group of counseling psychology training directors to formulate a series of manuscripts devoted to the topic of values and training. One of the goals of our work team is to formulate a model training values statement for the profession and to submit this statement to the Council of Counseling Psychology Training Programs (CCPTP) and SCP for endorsement.

Finally, our meeting in Washington, D. C. will soon be upon us, and I look forward to seeing many of you there. As you plan your schedule, I hope you can carve out time to celebrate with Cal Stoltenberg (University of Oklahoma). Cal will receive the APA Distinguished Contributions of Applications of Psychology to Education and Training Award at this meeting. You can hear his award address, entitled "Integrating science and practice in clinical supervision," on Friday, August 19<sup>th</sup> at 10 a.m. Congratulations, Cal!

This will be a great opportunity to demystify the process and to learn how you might approach this rewarding career development experience. It will be held from 9:00 to 9:50 a.m. on Saturday.

The Practice Organization website continues to provide a wealth of information and resources for practitioners at [www.apa.org/practice/](http://www.apa.org/practice/). For an overview of current issues, I suggest reading Russ Newman's keynote address to the State Leadership Conference, found at [www.apa.org/practice/slc\\_2005\\_speech.html](http://www.apa.org/practice/slc_2005_speech.html). One point of emphasis was on the potential

opportunities arising from the public focus on the effects of lifestyle, behavior, and stress on health and illness, a.k.a. the "mind-body connection." Another was about the challenges that face us regarding making treatments accessible and making psychology relevant to the public, and about bringing our current skills to new settings with new approaches. As counseling psychologists, we may be especially well poised to meet these challenges, as they fit well with our CP philosophy and practice.

One day last week, as I was pondering what to write in this farewell column, I had an interesting conversation with my hairstylist. I was telling her about my experience as a counselor, and she asked me, "So, has listening to people talk about their problems all day made you cynical?"

Before answering, I paused to reflect. For the past year, I've worked 20 hours a week at a community mental health clinic, providing individual and group therapy to clients with chronic mental illness. Many of them have experienced trauma, abuse, broken relationships, and the grinding effects of poverty and marginalization. Listening to their stories day after day would make even the most died-in-the-wool optimist pause for thought.

However, as I began talking through all this with my hairstylist (who is no slouch at reflective listening herself), I was reminded of my clients' courage in the face of suffering and their determination to make a better life for themselves. I realized that my experience as a counselor, rather than leaving me jaded, has actually made me more understanding of

people in general, more likely to be compassionate rather than judgmental. Also, counseling has given me a deep sense of humility in the face of the complexity of human problems.

"So, actually," I said, as she continued snipping away at my hair, "I think I'm probably *less* cynical now than when I started."

Having said this, I want to acknowledge that I could have easily sunk into a slough of negativity this year without the loving support of my family and friends. (Thank you, Mom and Dad! Thank you, Jenny! Thank you, Lucien, Sarah, Amy, Angela, Chris and Alison!) I am also grateful to my peers and mentors in the profession. The most useful antidote to cynicism that I've found is contact with caring, intelligent people who are doing their best to live well and make a difference in the world. Through my work as Assistant Editor of this newsletter, I have come into contact with many such people.

The first who comes to mind in this regard, for obvious reasons, is Michael Mobley. (Michael, I will miss working with you!

Thank you for teaching me about the workings of SCP, sharing your sense of humor and generous spirit, and modeling calm behavior in the face of deadlines and complications.) I have also enjoyed corresponding via e-mail with other SCP leaders, many of whom I had the opportunity to meet at last year's APA Convention. In particular, I was inspired by recent conversations with Shane Lopez, a man who exemplifies the spirit of Positive Psychology, and Tom Skovholt, whom I had the pleasure of meeting at the Wakonse Conference on College Teaching. Finally, I have been consistently lifted up by the warmth, caring, and positive energy of the faculty at the University of Missouri, especially Brent Mallinckrodt, Glenn Good, Roger Worthington, Norm Gysbers, and Puncy and Mary Heppner.

My position as Assistant Editor has been invaluable to me, and I am grateful to Michael and the Executive Board for making it possible. In addition to introducing me to leaders in our field, my work on the newsletter

### Call For Division 17 Fellowship Nominations

**Deadline: September 15, 2005**

Each year Division 17, the Society of Counseling Psychology, is given the opportunity to recognize members of the Division who have had significant impact on the specialty of Counseling Psychology. The impact pertains to the areas of science, teaching and training, service delivery, administration, policy development, and/or advocacy. Fellowship is an honor bestowed upon members who have made "unusual and outstanding contributions or performance in the field of psychology." Their contributions are viewed as having enriched or advanced Counseling Psychology well beyond the level that normally would be expected of a professional psychologist. Fellows are selected by peers on the basis of evidence of sustained superior performance that is recognizable at a national (rather than local or regional) level. Nominees must meet both APA and Division 17 requirements to be considered for Fellow status.

The APA requirements for Fellow Status are as follows:

- Receipt of a doctoral degree based in part on a psychological dissertation, or from a program primarily psychological in nature, and conferred by a graduate school of recognized standing.
- Prior membership as an APA member for at least one year and membership in the Division through which the nominations is made.
- Active engagement at the time of nomination in the advancement of psychology in any of its aspects.
- Five years of acceptable professional experience subsequent to the granting of the doctoral degree.

Additional requirements for Fellow status in Division 17 are:

- At least three years of post-graduate professional experience in counseling psychology.
- Membership in the Division for at least one year.
- Current engagement in education and training, practice, or research in counseling psychology.
- A significant and distinctive contribution

to Counseling Psychology in one or more of the following areas: Scientific Achievement, Professional Practice, Leadership and Administration, Teaching and Training, and/or Recognition of Excellence.

New Fellows must submit:

- Uniform Fellows Application
- Self-statement detailing contributions, evidence of contributions, and impact on Counseling Psychology
- Current vita
- Three endorsements from APA Fellows

For Current Fellows of other APA Divisions, only the following are required:

- Current vita
- Self-statement detailing contributions,

evidence of contributions, and impact on Counseling Psychology

- Letter of endorsement from an SCP Fellow

### Interdivisional Healthcare Committee Highlights from the Midyear IHC Meeting

The midyear meeting of the Interdivisional Healthcare Committee (IHC) was attended by Division 17 representatives Marilyn Stern and Timothy Elliott. The IHC addresses healthcare issues that are important to APA members and consists of two representatives from each of the following divisions: 17, 22, 38, 40, 55, and most recently, 12 (section 2). Geoff Reed and Randy Phelps from the Practice Directorate also attended the meetings. The IHC is an exemplar model for how APA divisions can work in an interdisciplinary fashion. Several important topics were discussed at the February meeting.

#### 1. Health and Behavior CPT Codes Updates and Survey Developments

- A resource newsletter for APA members who have paid their special practice assessment fee can be accessed through [www.APApractice.org](http://www.APApractice.org). Several examples of these articles were circulated, e.g., those that highlight the benefits in using the Health and Behavior (H&B) Current Procedural Terminology (CPT) codes and a series entitled, "Best of 2004."
- **Report:** Randy Phelps circulated a list of commercial third-party payers who are reimbursing for the H&B CPT codes; however, this list is not complete. We encourage members to inform Diane Pedulla of others who are and who are not reimbursing for the H&B codes.
- **State Leadership Conference:** A workshop format appears to be an effective and preferred way to educate members on the codes and reimbursement. One suggestion made is that each state psychological association take the lead in obtaining information about what is going on in each of their states by having a volunteer member collect data on CPT code reimbursement by private carriers.

### From the Federal Advocacy Coordinator

#### The Personal is Political

Personal experiences impact the bills that politicians sponsor in Congress. Painful life events have been transformed into important social legislation. Imagine what our public policies would be like if more counseling psychologists were elected to office...

- Senator Gordon Smith's (R-Oregon) tragic loss of his son to suicide resulted in the passage of the **Garret Lee Smith Memorial Act**. Smith's son, who suffered from bipolar disorder, killed himself on September 8, 2003. The bill passed Congress on September 9, 2004, the day that Garret would have turned 23 years old. The legislation authorized \$82 million over three years for youth suicide prevention programs, including voluntary screening.
- Congressman Ted Strickland (D-Ohio), a counseling psychologist trained at the

University of Kentucky, worked as a prison psychologist in southern Ohio. He saw firsthand how prisons have become *de facto* mental health facilities. With his passion and experience, he was able to gather bipartisan support for an important bill. The **Mentally Ill Offender Treatment and Crime Reduction Act** passed Congress in 2004. It authorizes \$50 million for states and local communities to fund mental health courts, jail diversion, treatment, and reentry programs. In the meantime, distressed about the state of affairs in his home state, Dr. Strickland announced he would run for Governor of Ohio in 2006.

- In 1996, Senator Pete Domenici (R-New Mexico) and Paul Wellstone (D-Minnesota) sponsored and Congress passed a limited mental health parity bill. It requires that lifetime and annual limits in insurance benefits are equal for mental and physical health. A conservative, Senator Domenici became a champion for

fair mental health treatment after his daughter was diagnosed with atypical schizophrenia. Senator Paul Wellstone realized the need for access to treatment after watching his older brother struggle with severe mental illness. Domenici continues to work for a comprehensive mental health parity bill. After Senator Wellstone's death, Senator Domenici renamed the full parity bill the **Paul Wellstone Equitable Mental Health Treatment Act**. The bill did not get out of committee in the last Congress, but Domenici promised to reintroduce it in 2005. ### 2. Medicare reimbursement to psychologists for H&B claims

- In 2002, a little over 1 million dollars was paid out; in 2003, over 6 million. From 2002 to 2003, there was over a 400% increase of submitted claims.
- It was noted that recent developments suggest that Medicare policies throughout the country may become more restrictive regarding number of units per year that will be reimbursed; check an article on this topic: [www.centerforhealthyaging.com](http://www.centerforhealthyaging.com).

### 3. International Classification of Functioning

- All the chapters of Body Function and Activities and Participation have been completed. The Environment section has not been completed. It is hoped that the entire manual will be ready for public comment by the fall.

### 4. New CPT Testing Codes and Survey Status

- Starting in January 2006, new psychology testing codes come out.
- These will differentiate among psychologists, technicians, and computer-based assessments. The possibility that students might then be able to bill as "technicians" was discussed.

### 5. National Health and Nutrition Examination Survey

- Helen Mitternacht from Public Relations requested feedback from members about possible roles for psychologists in this important study of the nation's health. We recommended that psychologists should be involved in the assessment procedures, selection of relevant measures, and data management. Public Relations will use this feedback to advocate for psychologists' involvement in this project.

### 6. Stress Eraser

- The Stress Eraser, a handheld biofeedback device, was demonstrated. It will be available for demonstration at the APA meetings.

### 7. Divisional Priorities/Issues for IHC

- Divisional representatives reported concerns for their respective Divisions. The IHC will continue communication with Divisions to guide long-term IHC strategic planning.
