and Northeast have probably seen more than enough snow to last for the rest of the season – I know I have. Ah, but the idea of all this snow should move us toward March, and our thoughts turn to Atlanta 2014!

Over the years I have assisted in planning all manner of events, from weddings to Great Lakes regional conferences to workshops. I was even the Program chair for the American College Personnel Association annual convention some years back. However, I had no idea, none, what this process was going to be like. This planning process has turned into a half-time job, and has sorely tested my ability to multitask. One last point in relation to Atlanta (well, for that matter, in relation to APA 2014, also). Back in the Dark Ages when I was a doctoral student, it was a given that we would attend professional conferences. I don't remember how we were indoctrinated into the cult, but I know there was never a doubt that we would be packing our bags and heading off to at least one convention a year. At this stage of my career, I go because it is the chance to see friends and colleagues, and to hear more about the work of others. In fact, it almost feels unnatural NOT to go to APA. Because it is in my blood, I sometimes assume everyone around me feels the same way. I forget that each successive class of students must also get that indoctrination. So, colleagues, if you have the opportunity to interact with trainees

or early career psychologists, take a little time to share with them why they should be members of SCP AND why they should spend the money to attend convention. Do not assume they know why it is important; they don't, and won't, until YOU tell them.

In other news, progress is being made on my second Presidential initiative (Atlanta was not the only thing on my mind last year!). If you recall, I have a strong interest in disaster mental health, and in getting more counseling psychologists involved in the training and research in this area. I asked SCP's Emergency Response Coordinator, David Romano, to organize a task force dedicated to increasing our presence in the national conversation. David identified four areas of possible involvement: Leadership; Training; Research and Theory; and Response. Through Leadership, counseling psychologists may participate in coalition groups involved in planning for National and International disaster events. This may include work with governmental and non-governmental organizations. Training opportunities can include developing curriculum for Undergraduate and Graduate classes in Disaster Psychology or developing tracks of specialization. It may also include peer training for community groups, as mental health professionals cannot be everywhere at once. Through Research and Theory development, counseling psychologists have the training to create, deliver, and evaluate approaches, interventions, assessments, and programs used in disaster situations. Response, of course, means that counseling psychologists can be on the front lines to provide a continuum of mental health service to clients, responders, communities (including educational communities), and organizations. If you are interested in learning more, there are several options available in Atlanta. First, David is offering an American Red Cross Disaster Mental Health Fundamentals course on Thursday afternoon (available for CE). Second, he has organized a workshop on disaster mental health issues on college campuses. And third, David is also planning an open forum for persons interested in the task force. Please check the Atlanta conference schedule for more information on these opportunities.

Finally, I'll end with an update on APA 2014. By the time this newsletter comes out, Program co-chairs Rosemary Phelps and Amy Reynolds will have completed their work and presenters should be notified. This has been a complicated year, with the introduction of APA's collaborative programming model and the significant reduction in Division programming hours. You

may be interested to know that 37 collaborative programs were submitted to SCP for review (9 of which listed us as the primary Division, while we were the secondary Division for the others). Ultimately, the Program Committee submitted 5 collaborative proposals to the APA committee; two of them were accepted. Several other collaborative programs include SCP as a secondary division. The committees that reviewed the collaborative submissions and the regular program submissions did a significant amount of work in a short time at an inconvenient time of year; thank you for your assistance! The Hospitality co-chairs, Sue Lease and Anthony Isacco, are now gearing up

for their planning, and the Awards and Recognitions committee, chaired by Chanda Corbett and the late Lonnie Duncan, is accepting nominations for the SCP student awards until February 15th. The Washington convention is the place to be for "Counseling Psychology in Action: Conversations, Collaborations, and Commitments to Change."

APA President Nadine Kaslow opened the Division Leadership Conference in January with a list of lessons learned as a division president. I was there in my role as Divisions Representative for APA's Committee on Early Career Psychologists (CECP), but most of the participants were division presidents-elect. As Nadine served as a division president in 3 different divisions, she had a lot of experience from which to speak. And she also acknowledged other past presidents she consulted, including one of our own past presidents, Jean Carter. In past talks, Nadine has mentioned her group of advisors, her "kitchen cabinet," and this time she talked about how as APA President, she works with an executive coach (2 in fact, who

give her different perspectives to consider). The relevant tip was "don't do it alone." She pointed out that we each have strengths as leaders, and we have weaknesses. Her strategy for this is to know her weaknesses and choose people to help her who are adept in her areas of weakness.

I have been struck by her model of openly talking about those who contribute to what she does as a leader. Without stepping back from taking credit or responsibility, Nadine infuses her communications with acknowledgement of those who help her to do her job. This aspect of her leadership style seems particularly relational to me. It reminds me of how Oliva Espin once opened a talk on women's spirituality by invoking the names of women who contributed to her own development.

In the last newsletter, I mentioned my own Advisory Council, my wise women advisors: Jean Carter, Linda Forrest, Monique Kulkarni, Anita Mihecoby. In talking with them about my role as VP for Communications, we discussed the history of the position, its original rendering and revision, and what makes sense moving forward. I was challenged by Jean's suggestion that I look at policies within my purview. Because I am still early in my career, the task of looking at policy is not usually given to me. I most easily think in terms of projects, and so I wanted to accept the challenge of taking on policy as a way to stretch myself and because I think it will most benefit SCP. I'm pleased to say that I have an excellent group around me for this task.

With Sharon Bowman's support, we began a Special Task Group, the Communication Policies STG, which will look at how SCP members use and would like to use our communication tools (listservs, website, social media, newsletter). Serving on the STG are Sonia Carrizales, Jean Carter, Michiko Iwasaki, Ginny Maril, Johanna Nilsson, Shari Robinson, and Aaron Rochlen. Perhaps by now you have already been surveyed by us about your own thoughts for how to use these tools. In dialogue with the current coordinators of these tools, we hope to see what is working well and what could be changed to respond to the needs of the Society. We will then send our best thoughts back to you for feedback. I encourage you to challenge us in your responses to us, letting us know how these tools can help you feel more engaged as an SCP member. How can our website, newsletter, listserv and social media be better used to make the work of SCP leadership more transparent, to foster connection among members, to support you in your own work and professional development?

## VICE PRESIDENT FOR EDUCATION AND TRAINING

In light of our upcoming Atlanta 2014 counseling psychology conference, I would like to share with you some programming highlights on education and training that I will be sponsoring/co-sponsoring. Most of these programs focus on either current topics of interest to trainers, early career professionals, and students, as well as topics that are perennial favorites. These are listed below:

First up is a symposium by Drs. Margo Jackson and Michael Scheel focused on issues surrounding masters' level training in counseling psychology. If you are interested in learning more about this critical topic affecting our field, you might want to review their excellent article in the July 2013 issue of *The Counseling Psychologist*. Drs. Jackson and Scheel will provide updates on masters training during this program.

Session day/time: **Friday, March 14, 9:10-10:40 a.m.**

Next is a Speed Mentoring session, co-sponsored with Vice President for Scientific Affairs Lisa Spanierman, in which

counseling psychology researchers (many of whom will be early career professionals themselves) will be available to speak with students and interested others about ideas and strategies for developing research projects.

Session day/time: **Friday, March 14, 12:45-1:25 p.m.**

Later that same afternoon is another session, co-sponsored with Vice President for Diversity and Public Interest Michele Boyer, on training perspectives in community/social justice advocacy. This session will involve a dialogue between panel members who have extensive experience working within community organizations and audience members who are interested in doing so.

Session day/time: **Friday, March 14, 1:30-3:00 p.m.**

Also that day, co-sponsored with Vice President for Scientific Affairs Lisa Spanierman, is a session focused on strategies for grant-writing, an increasingly important topic for counseling

psychologists of all backgrounds, from students to seasoned professionals.

### Session day/time: **Friday, March 14, 3:30-5:30**

Jim Lichtenberg will lead a Roundtable discussion on board certification in counseling psychology as this affects training programs as well as early career professionals and students. With the new health care law, board certification (also known as ABPP), along with licensure, will become increasingly critical to obtain for practitioners. Come and speak with experienced colleagues about your questions for becoming board certified and learn about available resources.

### Session day/time: **Saturday, March 15, 9:10-10:40**

The next morning begins with a presentation by Dr. Cynthia Belar, Executive Director of the APA Education Directorate. She will be presenting on developing competencies for working in health care settings, including hospitals and counseling centers. Dr. Belar is highly knowledgeable about the many aspects of working in these complex settings, and will address how counseling psychologists can develop expertise for working in multidisciplinary teams.

### Session day/time: **Saturday, March 15, 9:10-10:40 a.m.**

That same day, Drs. Carol Falender and Cathi Grus, along with a panel of experts, including Rod Goodyear and Michael Ellis, will present a workshop on the guidelines for clinical supervision that are currently in development. You will have an opportunity to hear about competencies and perspectives from

the folks who wrote many of the supervision textbooks we use in the field.

### Session day/time: **Saturday, March 15, 1:30-3:30 p.m.**

Finally, in a session co-sponsored with Mary Ann Covey, liaison from Association for University and College Counseling Center Directors (AUCCCD), Drs. Linda Forrest and Kathy Bieschke will lead a workshop on updates regarding values conflicts. Given some recent court decisions in this area (see the excellent series of articles on this topic in the November 2012 issue of *Training and Education in Professional Psychology*), this session will provide important updates and strategies for both students and professionals about how to manage these conflicts while still striving toward and maintaining professional competence.

### Session day/time: **Sunday, March 16, 9:00-10:30 a.m.**

I also look forward to hosting a dinner with Dr. Arlene Noriega on Latinas/os in psychology (titled *¡Qué Pasa, U.S.A.!: The Latina/o experience in the US*) at the Tijuana Garage on Friday, March 14 at 7 p.m.

Settling into my role as VP of Scientific Affairs has provided several insights. We need to do a better job as a discipline realizing the scientist-practitioner model. Our multicultural and social justice emphases offer a natural pathway to conducting rigorous empirical research that makes a difference in society! We must foster research collaborations with community partners and find creative ways to bring our research findings to the public.

If you have not already done so, please familiarize yourself with APA's Science Directorate and the Science Student Council. Their mission to represent and promote psychological science is relevant to academics, practitioners, and graduate students. For example, students and professionals alike can learn ways to get involved in science advocacy. You might consider subscribing to the Science Directorate's e-newsletter, *Psychological Science Agenda*.

Science training remains one of my top initiatives. Conducting empirical research on what we do to promote mental health and well-being is crucial to the future of our field. My graduate students in *Advanced Theories* recently read a special issue in *Canadian Psychology* that features progress monitoring, and it was joyful to observe their excitement about conducting research on their own clinical practice.

I am grateful to Meifen Wei, Rachel Navarro, Kevin Cokley, Marty Heesacker, and Bryan Kim (i.e., SCP's Science Advisory Board) for all of their hard work in preparation for Atlanta 2014. We have lined up some exciting programs that focus on counseling psychology science:

- *Everything You Ever Wanted to Know About Science but Were Afraid to Ask* is a speed-mentoring event to connect members with leading counseling psychology researchers (with VP Education & Training).
- *Show Me the Money: Grant Getting Tips for Counseling Psychologists* is a 2-hour workshop featuring Dorothy Espelage, Rachel Navarro, and Scott Solberg (with VP Education & Training).
- *Special Considerations When Doing International Science* will focus on issues of language, culture, ethics, and dissemination (a joint symposium with the International Committee).
- In a symposium titled, *Revise & Resubmit: Insights from Journal Editors* (TCP, JCP, PWQ, JBP, & JDHE), you will learn about their visions for their respective journals, along with trends, tips, and strategies for getting published.
- *Thriving in Colleges of Education: Research Matters* is a symposium to help scientists align their research with missions in colleges of education.
- Please find time to attend a Conversation Hour with the Executive Director of APA's Science Directorate, Dr. Steven Breckler (<https://www.apa.org/about/apa/senior-staff/breckler-bio.aspx>). He is making a special trip from DC to meet our members and exchange ideas.

I've been a counseling psychologist for quite a while—not as long as some but longer, I suspect, than most. My professional home is the University of Kansas where I served 34 years as training director for its counseling psychology program, as director of its counseling center, and now as Associate Dean for Graduate Programs and Research.

### PREVENTION SECTION

The Guidelines for Prevention in Psychology were approved as APA policy during APA Council meetings in February 2013. The Council approved the Guidelines after they received unanimous support from APA's Board of Directors in December 2012. The Guidelines offer guidance to psychologists in supporting the value of prevention as important work of psychologists, and in providing recommendations that give greater visibility to prevention among psychologists regardless of specialty area or work setting.

While APA approval of the Guidelines is an historic step, it is only the beginning, as next steps must include broad dissemination, infusing their content into the education and training of psychologists, strengthening prevention goals in the science and practice of psychology, and promoting prevention as critically important to all of society. Members of Division 17 are especially welcome to join in this effort, and may contact John Romano at [roman001@umn.edu](mailto:roman001@umn.edu) or Sally Hage at [shage@springfieldcollege.edu](mailto:shage@springfieldcollege.edu).

### Program for 2014 APA Convention in Washington, DC

The Program Committee is excited to report that the Society's program for the American Psychological Association 2014 Annual Convention in Washington, DC has been submitted. We are deeply grateful to Debbie Nolan, our Society's Association Manager, and Skylar Siminovsky, Association Executive, for their incredible and significant contributions to processing proposals and directing logistics during our review of programs.

Our convention program cannot come to fruition without the support of all Society members, both professionals and students, who submitted their scholarly work to the Division. The 2014 convention theme for Division 17, Society of Counseling Psychology (SCP), is "*Counseling Psychology in Action: Conversations, Collaborations, and Commitments to Change.*" Consistent with this theme will be Society President, Dr. Sharon Bowman's presidential address entitled "Conversations and collaborations: So, what has really changed?"

After receiving 66 proposals for Symposium/Discussions and 335 proposals for poster sessions, our committee worked diligently to read and review each proposal. Our final convention program will feature 200 posters and 32 Symposia or Discussions. Our poster presentations will consist of the following 5 clusters: (1) Vocational and Career Development; (2) Scale Development, Measurement, and Evaluation; (3) Mental Health and Well-Being; (4) Multicultural, Social Justice, and Advocacy; and (5) Counseling Interventions, Strategies, and Treatment. Our symposia/discussion presentations will address topics such as counseling psychologists in diverse settings, interdisciplinary collaborations, multicultural counseling and social justice, future directions in counseling psychology, health psychology and health promotion, training and supervision in counseling, and prevention. The program contains information relevant to populations across the lifespan and to diverse populations. Thirteen sessions have applied to offer Continuing Education (CE) credits.

This is the first year of the collaborative program initiative for the annual convention. The Program Co-chairs initiated five collaborative program proposals and eight proposals were submitted to us from division members. A divisional collaborative

review committee was formed, and the committee reviewed all submissions. The collaborating divisions also reviewed them. Five proposals were submitted to the Collaborative Programming Group (CPG) for review. Of those five submissions two were chosen by CPG as collaborative programs for Division 17. On 10 collaborative programs chosen by CPG, Division 17 will be a collaborating division. We feel positive about our first experience with collaborative programming, and look forward to developing more collaborations in the future.

Programming has been tentatively scheduled and submitted to APA (*therefore there still may be date and time changes*). We will receive final notification on our schedule from APA in late March. This year the Leona Tyler Award recipient, Dr. Steven D. Brown of Loyola University – Chicago will give his acceptance speech on Thursday, August 7 (1:00-1:50 pm). Our Society President, Dr. Sharon Bowman, will deliver her presidential address on Saturday, August 9 (2:00-2:50 pm), followed by the Division Business meeting (3:00-3:50 pm). There will also be two social hours (August 7, 5:00-5:30 pm and August 9, 4:00-4:50 pm). There are two other important addresses scheduled for Friday, August 8th: the Fellows Addresses (4:00-5:50 pm) and the SAW Award of the Year address (11:00-11:50 am).

With Dr. Bowman's Presidential Initiative primarily focused on the upcoming SCP Conference in Atlanta, she graciously donated her convention hours to two important groups: Early Career Psychologist Committee of SCP and The Higher Education Mental Health Alliance (HEMHA). They will be offering two interesting programs: Gaining wisdom from Counseling Psychology changemakers (Early Career Psychologists Committee) on Saturday, August 9 (9:00-9:50 am) and The Higher Education Mental Health Alliance (HEMHA): Who we are and what we do on Friday, August 8 (1-2:50 pm). We hope you find the convention program intellectually informative and stimulating in regards to the research, theory, practice, training, supervision, and consultation foci within Counseling Psychology.

1. *Three copies of the manuscript resulting from the research.* The manuscript should be in APA format and **no longer than 20 typed, double-spaced pages including tables, figures, and references.** Papers exceeding this limit won't be considered.
2. *A letter from the student's faculty advisor.* The letter should describe the degree to which the candidate had responsibility for the project objectives, design, data collection, data analysis, and manuscript preparation.
3. Submissions will be accepted right away but must be received **no later than June 1st, 2014.** Faxed copies will not be accepted. The paper and letter from the faculty advisor should be emailed to [MKeitel@Fordham.edu](mailto:MKeitel@Fordham.edu) and 3 hard copies mailed to the address below.

## Counseling Psychology's Recognition as a Specialty Renewed

In 1995, the APA established CRSPPP, the Commission for the Recognition of Specialties and Proficiencies in Professional Psychology. CRSPPP was founded out of a recognition by APA Council of the need for a mechanism by which “specialties” within applied psychology could be recognized. The need grew out of the rapid growth in psychology’s scientific and professional knowledge and their areas of professional application and, given the burgeoning of self-proclaimed psychological specialties, the importance to the public (and to the profession) of having a means by which psychology could say that a particular group or practice constituted a practice specialty recognized by the larger psychological community.

Fundamental in this endeavor was defining what a specialty is, and the following definition was adopted:

*A specialty is a defined area of professional psychology practice characterized by a distinctive configuration of competent services for specified problems and populations. Practice in a specialty requires advanced knowledge and skills acquired through an organized sequence of education and training in addition to the broad and general education and core scientific and professional foundations acquired through an APA or CPA accredited doctoral program. Specialty training may be acquired either at the doctoral or postdoctoral level as defined by the specialty. (retrieved from the CRSPPP website: <https://www.apa.org/about/policy/principles-recognition.pdf>, January 25, 2014)*

Key features of this definition—and of what is required of psychological practices to be recognized as a specialty—are three criteria: (a) a distinctive configuration of competent services, for (b) specified problems and (c) specified populations.

At the outset, counseling psychology was recognized as one of four *de facto* specialties; along with clinical, school and I/O psychology, counseling psychology was presumed to be a specialty...at least for the time being. While recognizing the need

to recognize the emergence of new specialties, CRSPPP also recognized that with changes in the profession, existing specialties might change in ways such that they would no longer be recognized as specialty. For this reason, CRSPPP requires that specialties petition for renewal of their recognition as a specialty. This occurs every seven years.

The petitioning process is no small task; and for those who are interested, it is instructive to review the petition instructions (visit <https://www.apa.org/ed/graduate/specialize/specialties.aspx>). Considerable documentation is required, and preparing the petition is time consuming and shares some similarities to preparing an accreditation self-study.

Counseling psychology has gone through the petitioning process three times—the most recent being 2011-12. Each time, the SCP President has commissioned a special task group (or writing group) to prepare and submit the petition on behalf of SCP. The most recent writing group (appointed by then-President Barry Chung) was Jaquie Resnick, Takuya Minami, and Jim Lichtenberg. The petition draft was reviewed by the executive board of SCP and of CCPTP (Council of Counseling Psychology Training Programs). It was also shared with the Counseling Psychology Synarchy, which Jaquie Resnick represented on the special task group. Subsequent to those reviews, the petition was submitted to CRSPPP. After its review of the petition, CRSPPP recommended to APA Council that a renewal of counseling psychology’s recognition as a specialty be deferred for a year to allow for clarification and strengthening of our response to certain points within the petition. Clarifications were made to the petition, additional information was

provided, and CRSPPP then recommended to APA Council that Counseling Psychology's recognition as a specialty be renewed for another seven years. Council approved that recommendation this past August.

Because of its value as an archival and reference document regarding counseling psychology, the petition is being made available online through the SCP website (<http://www.div17.org/> under RESOURCES). Admittedly it is not exciting reading, but it is important reading.

Counseling psychology has for quite some time wrestled with its identity. Although that wrestling may continue, the petition serves as a formal statement of those characteristics and those dimensions of practice that define the field as a specialty. The petition is counseling psychology's claim and statement to the larger profession that this is what we are—this is what we do. That being said, the text of the petition necessarily must comport with the strictures and criteria established by CRSPPP in its definition of a specialty. Our case, our arguments for being a specialty needed to address the CRSPPP's definition of a specialty. And therein was the problem for counseling psychology and for the writers of the petition: making the case for counseling psychology's distinctiveness from other psychological specialties in terms of its configuration of services, the problems it addresses and the populations it serves. Our overlap with other specialties within professional psychology in terms of what we do, where we do it, to whom we do it, and for what problems we do it, can make our distinctiveness difficult to articulate and demonstrate. This is not to disregard counseling psychology's core and guiding values, but having distinctive values is not a criterion for a specialty—although they echoed throughout the petition. The writers of the petition did their best to make that case for counseling psychology's distinctiveness as a specialty, and they were successful. (I personally find it disturbing to think what the implications would be were counseling psychology to lose such a recognition.)

Like other applied specialties in psychology, counseling psychology continues to evolve as a profession—in part as a function of social, political and economic factors, and in part as a function of the growth of psychological science and technologies. Because of these factors, client populations, client problems, and interventions that once were distinctive to other specialties have become incorporated into counseling psychology; and populations, client problems, and interventions that once were distinctive to counseling psychology have become part of the scope of practice of other specialties. A focus on strengths and positive aspects of human functioning, on prevention, on diversity and multiculturalism, and on social justice—all of which were prominently discussed and displayed in the petition—are not unique to counseling psychology—and they shouldn't be any more than a focus on the integration of psychological science and professional practice. To be sure these are core values of our profession—but they are also values shared with other divisions and practice specialties. It is reasonable to expect that such elaboration and assimilation will continue to characterize the growth of professional psychology.
