PRESIDENT-ELECT'S REPORT

A Great Time to Be a Counseling Psychologist



It is early in May as I write this column for the summer newsletter. It is a beautiful spring day in Eugene and summer does feel right around the corner. Much of what I describe as happening today will have moved forward in major ways by the time the newsletter is in your hands.

First and foremost, I want to describe the efforts of all the people involved in planning the 2008 International Counseling Psychology Conference to be held March 6-9, 2008 at the Chicago Hilton and Towers. This will be the fifth time the counseling psychology profession has hosted its own conference. Unlike previous conferences reflecting a national perspective, this will be the first counseling psychology conference promoting an international mission. So spread the work to your international colleagues. Also, we are looking for practitioners who would like to get more involved in planning the conference. We want to make sure that the conference program is relevant to practitioners across the spectrum of work environments. Also, we need your help planning Continuing Education Workshops especially designed to meet your professional needs.

The Conference Steering Committee (consisting of members from SCP, CCPTP and ACCTA who I have identified in previous columns) has established several confer-

ence subcommittees, all of which are hard at work developing the plans for the conference. The subcommittees and their chairs are listed below. If you are interested in getting involved in the planning process, contact any of the subcommittee chairs or Debbie Nolan (conferenceplanner@icpc2008.org).

All of the Sections of the Society are also planning preconference activities on Thursday, March 6th. If you are interested in being involved in the planning process associated with Sections, please contact your Section Chair. Details associated with these preconference Section activities will be added to the conference website as the plans develop. Currently, our plans are to have the general "Call for Program Proposals" available by July 2007 on the conference website, www.internationalcounselingpsychologyconference.org. Program options will include symposia, poster presentations and working groups on topics of interest to counseling psychologists (working groups will have a similar format to the social justice work groups at the Houston conference in 2001). Details about each of these options will be described in the "Call for Proposals." The deadline for submission of program proposals will be September 15, 2007, and notification about acceptance will occur by mid November and prior to the "Call for Programs" for APA in 2008. Lots more information about the 2008 International Counseling Psychology Conference will be available at the SCP Annual Business Meeting and in the SCP Hospitality Suite at the APA convention in San Francisco. Join us then to learn more about the 2008 International Counseling Psychology Conference or visit the website.

APA COUNCIL OF REPRESENTATIVES REPORT

One of the controversial issues on the Council listserv this spring was discussion of the role of psychologists in US Detention Centers. Neil Altman, as representative of Division 39, Psychoanalysis, will introduce a resolution for a moratorium on all psychologist involvement, either direct or indirect, in any interrogations at U.S. detention centers for foreign detainees. He has asked that other social justice divisions join in support of this resolution. A number of them have.

The rationale for this resolution is that "this moratorium is necessary as detainees may be currently denied protections outlined under the Geneva Conventions and interrogation techniques in violation of the 2006 APA Resolution Against Torture and Other Cruel, Inhuman, or Degrading Treatment or Punishment may be considered acceptable practice according to the Military Commissions Bill of 2006". They feel Psychologists may be placed in untenable positions and that "through this moratorium, APA public policy can communicate to the public a clear message about the fundamental human values on which American psychological research, practice, and consultation are based and evaluated."

Other voices include Division 19, Military Psychology, and the Ethics Committee of APA. Military psychologists contend that Psychologists often provide an important positive effect in training interrogators in safe

and effective ways, based on the fostering of rapport, of questioning detainees. Two of the last APA Presidents explored the roles of Psychologists, asked for any examples of inappropriate or unethical behavior by Psychologists in U.S. Detention Centers and found no evidence of coercion or punishment for communicating concerns or refusing to participate in a consultation on ethical grounds.

Dr. Michael Gelles in a letter to Dr. Altman, summarizes that "we all seek the same goal: An ethical means of eliciting accurate and reliable information in order to prevent acts of violence and loss of life." He states that "through the PENS Task Force and subsequent Council of Representative actions, APA is playing a critical role in bringing moral clarity to the debate over what constitutes an ethical consultation to an interrogation, as well as science to the practice of interrogations. Removing psychology and psychologists would stop the steady and measurable progress we have made and are making. From my perspective, a moratorium would be to abdicate rather than to embrace our ethical responsibilities."

The Ethics Committee has proposed a case book project and at least one amendment that could be made to the Ethics Code to strengthen/clarify these issues with respect to international law. They are promoting collaborative efforts as a whole community to find language that will receive strong and

wide support from the entire community of Psychologists for Council to adopt.

The SCP Executive Board discussed supporting this resolution during a conference call in May. We had a mixed perspective, though the majority vote was not to support the call for a moratorium. Our position may be best summed in Sandra Shullman's analysis that the call for a moratorium appears to have become an objective (albeit divisive) unto itself. It was Military Psychologists, in the first place, who contacted APA for help from their professional organization. There is no evidence of psychologists either participating in or "cleaning up" after inappropriate actions had occurred. Our military colleagues are looking for support from their professional organization, not a moratorium on all behavior that could be related to interrogatory activity and could affect police and correctional psychologists as well.

This issue will foster continued debate as good people promoting ethical behavior will have differing opinions and world views on the proper role of Psychologists and APA within cultural context and political climate. We hope you will continue to educate yourselves on the complexities of this issue and make your opinions known to your Council Representatives.

vide audience members with the opportunity to learn about the various disciplines within counseling psychology. A panel of professionals will present on the variety of disciplines within the field, including academia, private practice and health psychology. We hope you join us to learn more about the opportunities available within the field, as well as take advantage of the opportunity to network with other students and professionals.

As our three-year term comes to an end, we're busy working with the University of North Dakota to ensure that the transition of SAS is as smooth as possible. After they take over SAS leadership we'll likely have a little more free time on our hands, but hosting SAS has been one of those demanding life experiences void of regrets and filled with thanks.

VICE PRESIDENT FOR DIVERSITY AND PUBLIC INTEREST

I would like to take this opportunity to update you on a number of different projects in which I have been involved this year. The planning for the Evidence-based Practice with Ethnic Minority Populations conference is moving along and finally, after months of hard work, enough funds have been secured to make this a reality. It has been difficult to identify a date for this conference that does not overlap with existing meetings such as the 2008 International Counseling Psychology Conference, the Annual Meeting of AERA, and APA's Consolidated Meetings, etc. At this time, it appears that the conference will happen in March 2008, although no contracts have been signed, so that timeframe may change. As soon as there is a confirmed date and place, I will let all of you know so that you can plan accordingly.

On another front, I have been participating in an effort to modify the language contained in Domain D of our Accreditation Guidelines. Specifically, Ray Crossman, Laurie Mintz, Joe Ponterotto, and myself put together language

that asked academic programs to have plans and outcomes related to their recruitment and retention of diverse students. The proposed changes were reviewed by CCTC and the Ethnic Minority Psychology Associations' Presidents. While the latter group supported these changes, there were mixed reactions from members of CCTC largely based on the critique that ethnic and racial representation is a bigger challenge for universities located in non-urban settings. At this point, the planning group is discussing whether there is a way to modify the language in such a way that the proposal would be more widely supported or whether it should be presented to CoA, even with limited support. In either case, we remain committed to this endeavor and I will keep the Society posted with future developments.

Finally, with regard to the 2008 International Counseling Psychology Conference, as VP of Diversity and Public Interest, I will be given a block of hours for invited presentations on issues related to multicultural counseling, social justice, and

other public interest topics. I very much need the input of our membership to help me determine what kinds of presentations you would like to see at the conference. There has been a lot of emphasis at other conferences like the Multicultural Summit and the Winter Roundtable on topics such as multiple identities, social justice practice and research agendas, and evidence-based intervention with ethnic minority groups. My own vision is that we should aim to program sessions that represent the "cutting edge" in multicultural counseling psychology where we look toward the future. Many of you are doing such cutting edge research. So please contact me via email with your ideas, general or specific, for what you see as groundbreaking work in this area. Feel free to contact me for any other questions or concerns you have. Until then, Happy Summer and see you at Convention in San Francisco!

VICE PRESIDENT FOR SCIENTIFIC AFFAIRS

As you may have noticed, the 2008 International Counseling Psychology Conference (ICPC) is beginning to generate a bit of buzz. In fact, preparations for the ICPC have revved up over the past several months, with lots of committees working to plan this historic event. As VP for Scientific Affairs, I want to encourage the very best science programming that we can muster, showcasing all areas of our inquiry.

Most of the ICPC's programming will be based on an open call for papers, but each of the four VPs will also be able to generate a few invited sessions. I welcome your suggestions for science-related sessions. Think of key topics and speakers that you would like to see included. Given the overall theme of the conference, I would like to focus part of our energies on research needs or advances on the international front (e.g., international research collaborations). You can email me your suggestions.

The ICPC will also include working groups on defined topics of interest. Think of particular science challenges or problems that

need tackling and that would lend themselves well to several hours of sustained face-to-face group dialogue, leading to some defined product (e.g., a journal article or special issue). These could be situated within particular areas of inquiry or, better yet, of relevance across multiple areas of inquiry. I would be happy to discuss suggestions you may have for science-related working groups, although a separate planning group will be responsible for soliciting or selecting proposals.

Speaking of conferences, I look forward to seeing everyone at the upcoming APA convention in San Francisco. Several counseling psychologists will be receiving prestigious APA awards there, marking their contributions to the science or profession of psychology. In particular, Bruce Wampold will receive the Award for Distinguished Professional Contributions to Applied Research, and Fred Leong will receive the Award for Distinguished Contributions to the International Advancement of Psychology.

The science-related contributions and activities of our members will also be well-

displayed within SCP's convention programs. I would especially like to highlight the Best Science and Best Practice invited presentations (see also box on page 22). Tim Elliott will also be facilitating a panel discussion on counseling psychologists' experiences in obtaining external funding.

Finally, still on the theme of conferences – and international ones, at that: kudos to Paul Gore, David Blustein, Donna Schultheiss Palladino, Barry Chung, Darrell Luzzo, and other SCPers for their roles in organizing a three-way conference involving the Society for Vocational Psychology, the National Career Development Association, and the International Association of Educational and Vocational Guidance, which will be held this September in Padova, Italy. It is exciting to see counseling psychologists' increasing collaborations across national boundaries, making our specialty truly global in nature.

VICE PRESIDENT FOR PROFESSIONAL PRACTICE

APA response to the Virginia Tech tragedy. From previous experience the Practice Directorate was quite well prepared. Several disaster response psychologists were on hand to help the Red Cross and a number of APA materials were on hand and posted to web sites, including Virginia Tech's home page, such as the warning signs of school violence and the materials on resilience. Thanks also to Karen Settle, Chair of the Division 17 Section on college and university counseling centers, who was called on by the Practice Directorate to review and edit the material being sent out. Karen also attended the CAPP (Committee for the Advancement of Professional Practice) meeting to make the case for Division 17's membership in the Integration Group which provides feedback to CAPP from various practice stakeholder groups. The experience at Virginia Tech emphasizes the vital role of college counseling services and counseling psychologists in campus mental health.

National Provider Identifier (NPI). Psychologists in independent practice should be aware of the national ID number required by HIPAA that will replace all individual IDs provided by Medicare, CHAMPUS and individual insurance companies on May 23, 2007. In fact, both NPI and original ID numbers should be used until the individual insurance company sends indication that they have received and recorded your NPI. Recently the Centers for Medicare and Medicaid Services

(CMS) sent a memo giving an extra grace period for compliance. Online application is to <http://www.cms.hhs.gov>. Without consulting the APA, CMS created a series of psychology specialty labels for selection. One of these is Counseling Psychologist and it is yet unclear whether any insurance companies might use these specialty labels to restrict or deny reimbursement. While, hopefully, this concern is somewhat hypervigilant, the Practice Directorate in its Monitor articles and website commentaries suggested that the generic clinical psychologist can be used. Psychologists can re-enter the online website above and edit their profile at any time.

Pay for Performance. As mentioned in the last Newsletter, the development of evidence-based treatments (in medicine as well as psychology) has (not surprisingly) been picked up by insurance programs (Medicare has initially Pay for Reporting). These programs will offer financial incentives to participants who participate. Blue Cross-Blue Shield, for example, has Bluecompare which develops an Affordability Scale and an Evidence Based Measure (EBM) Ribbon which will eventually include psychologists when specialty data has been modeled. APA Practice Directorate is following this initiative carefully and, while avoiding being defensive to a concept that is in itself obviously reasonable, is pushing for a comprehensive view of quality including relationship and

common factors in the operational definition of quality.

Division 17 membership. In the last few months we have explored the demographics of Division 17 and there are some notable facts. Only 26% of our membership is under the age of 50, so we seem to be losing our new professionals. Many of us in training programs know that our doctoral students are APA and Division 17 members when they graduate, so the loss of membership is often after graduation. Also, there are 10,000 members of APA who graduated from counseling psychology programs but who are not members of Division 17. It is likely that, in addition to losing new professionals (other divisions are having similar problems) we are losing practitioners. Among approximately 3000 university and college counseling practicing psychologists, only between 700-1000 (counseling center as primary and secondary job position, respectively) are APA members, and not necessarily Division 17 members. Clearly, this is a Division 17 issue but it is also a practitioner issue. As we plan for the 2008 International Counseling Psychology Conference (Chicago, March 6-9) we are planning to engage as many counseling psychology practitioners for the conference and beyond.

VICE PRESIDENT FOR EDUCATION AND TRAINING

Three years ago I was elected SCP's Vice-President for Education and Training; I attended my first executive board meeting in Hawaii. I remember feeling overwhelmed by the task before me and wondering how I might be able to contribute to education and training issues in counseling psychology. So many issues to master...not to mention an extremely long list of acronyms. After three years, I think I've finally figured it out and it's already time to say adieu.

When I consider what I've been able to accomplish these past three years, I'm probably most happy that the Counseling Psychology Model Training Values Statement Addressing Diversity was endorsed by CCPTP, SCP, and ACCTA in summer of 2006. in training communities. Probably what I enjoyed most about that initiative is the collaborative way in which representatives from all three organizations worked together to craft a statement that represented each of our perspectives.

Working collaboratively has been my experience throughout my tenure in this position-both within counseling psychology as well as within the field of psychology. For example, I've been very fortunate to be involved with a number of pressing accreditation issues and to be able to add my voice (and the voice of counseling psychology) to the dialogue. Though I'm sometimes frustrated that progress on issues seems to proceed slowly, I do have the sense that there is forward movement. I very much hope that my successor continues to work towards collaboration; that can only

happen if s/he works to be a visible presence for education and training issues both within SCP and APA.

Thanks for giving me the opportunity to serve in this position. It's been a privilege and a pleasure. I wondered whether I'd tire of thinking about the education and training of counseling psychologists and believe it or not, I haven't. In fact, the more I know, the more I realize there is to know. I'll continue to bring this energy to my associate editor position for the Training Education of Professional Psychologists-send me something interesting and fit to print!

Practice climate in counseling psychology training programs. It is not uncommon to hear doctoral students privately admit that their goal to be practitioners has to be kept a close secret in their programs - especially in the case of independent practice. Practice, and even practice training, in the highly research intensive (and extramural funding) emphasis in many of our programs, has increasingly low priority. We understand that a Ph.D. implies a conceptual and leadership role that goes beyond (but is not necessarily superior to) one-to-one outpatient psychotherapy. However, it is surely an anomaly that we spend so much program time and effort on theory and research on psychotherapy processes and counseling training and then frown on actual practice of these skills? These issues might perhaps be pertinent in understanding why many of our practitioner graduates do not find a home in our Division?

(e.g., nursing homes, schools for physically and emotionally challenged children), community-based programs, detention and prison settings for juveniles and adults, and private clinical contexts.

- The use and effectiveness of prevention programs using animal-assisted approaches, especially those targeted at children at risk.
- The provision of information to other relevant groups in psychology and the Association on the role of animals in human health—both physical and psychological.
- The link between animal abuse, family violence and juvenile delinquency.
- Dissemination of materials to training and educational institutes, as well as government agencies, about the role of animals in family and community life. For example, Hurricane Katrina vividly demonstrated that for the psychological and physical safety of families (including their pets), animals need to be considered in emergency disaster and preparedness planning and response.

Psychotherapy Science

This year, psychotherapy science is once again prominent in the Society of Counseling Psychology APA program. Mark your calendars for these section-sponsored events, as well as the other psychotherapy science sessions at the convention.

The section sponsored session at this APA convention is entitled Exploring the Real Relationship: A Tribute to Dr. Charles Gelso. Selected to receive the Section for the Promotion of Psychotherapy 2007 Science Lifetime Contributions Award, Charlie Gelso has made innumerable contributions to psychotherapy science theory, research, practice, and training. In this session, three researchers who have collaborated with Dr. Gelso will discuss recent work on the real relationship. Dr. Gelso will comment on this research, reflect on his own research and career, and provide various insights on the therapeutic relationship. The Lifetime Contributions Award will be presented during this session. Also during this session, the SPPS First Annual Student Research Award will be presented to Wonjim Sim for her study, "East Asians or East Asian Americans' Preferences for Different Types of Psychotherapy," in which she found that East Asian

and East Asian American participants were not different from a mixed American sample in their preferences for insight- versus action-oriented approaches, and she identified new potential predictors of session evaluations for these clients. Ms. Sim is currently a student in the Counseling Psychology program at the University of Maryland.

Members of the Section for the Promotion of Psychotherapy Science have also joined forces with members of the Independence Practice Section in a session entitled, Evidence-based Practice: Practice, Research, and Social Justice Considerations. In this session, Emily Cate will discuss training issues from a student's perspective. Gargi Roysircar-Sodowsky will discuss developing and testing culturally sensitive treatments. Terry Schwartz and Susan Lonborg will discuss community psychology and public health considerations. Call For Division 17 Fellowship Nominations

Deadline for Nominations: September 15, 2007

Each year Division 17, the Society of Counseling Psychology, is given the opportunity to recognize members of the Division who have had significant impact on the specialty of Counseling Psychology. The impact pertains to the areas of science, teaching and training, service delivery, administration, policy development, and/or advocacy.

Fellowship is an honor bestowed upon members who have made "unusual and outstanding contributions or performance in the field of psychology." Their contributions are viewed as having enriched or advanced Counseling Psychology well beyond the level that normally would be expected of a professional psychologist. Fellows are selected by peers on the basis of evidence of sustained superior performance that is recognizable at a national (rather than local or regional) level. Nominees must meet both APA and Division 17 requirements to be considered for Fellow status. The APA requirements for Fellow Status are as follows:

- Receipt of a doctoral degree based in part on a psychological dissertation, or from a

program primarily psychological in nature, and conferred by a graduate school of recognized standing; prior membership as an APA member for at least one year and membership in the Division through which the nominations is made; active engagement at the time of nomination in the advancement of psychology in any of its aspects; and five years of acceptable professional experience subsequent to the granting of the doctoral degree. Please note, however, that it is highly unusual for applicants to be awarded Fellow status within 10 years of the granting of the doctoral degree.

Additional requirements for Fellow status in Division 17 are:

- At least three years post-graduate professional experience in counseling psychology; membership in the Division for at least one year; current engagement in education and training, practice, or research in counseling psychology; and significant and distinctive contributions to Counseling Psychology in one or more of the following areas: Scientific Achievement, Professional Practice, Lead-

ership and Administration, Teaching and Training, and/or Recognition of Excellence.

New Fellows must submit a Uniform Fellows Application; a Self-statement detailing contributions, evidence of contributions, and impact on Counseling Psychology; a current vita with "R" by listings of publications in refereed journals; and three endorsements from APA Fellows, including the Fellow Status Evaluation Form and Fellow Status Evaluation Worksheet.

For Current Fellows of other APA Divisions, only the following is required: a current vita; a self-statement detailing contributions, evidence of contributions, and impact on Counseling Psychology; and a letter of endorsement from a SCP Fellow.

Any member or Fellow of Division 17 may make a nomination. Self-nominations also are invited. Nominations should be sent via regular mail or e-mail to the Chair of the Fellows Committee:

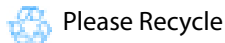
