Silvia Sara Canetto, Ph.D. and colleagues recently published a 20-country study that provides evidence of a suicide-protective role for men who engage in family carework. This study found that in countries where men reported more carework, men's suicide rates were not higher when unemployment rates were higher. By contrast, in countries where men reported less family carework, higher unemployment rates were associated with elevated male suicide rates. Unemployment programs did not reduce male suicide rates. The study's findings suggest incorporating support for men's engagement in family carework in programs aimed at reducing men's suicide mortality. "This means expanding beyond dominant frameworks of men's suicide prevention, and their employment-support focus," Dr. Canetto explained in an interview. This study's findings, together with those of many other studies, suggest that "having both family care work and family economic responsibilities is more conducive to well-being, health and longevity for men and women than a gendered division of family labor," said Dr. Canetto.
